We wish to inform that the definition of "Dormant" and clause 9(i) of TAIB's Terms and Conditions have been amended and shall take effect from **1 January 2019**:

		New/ Revised Clause
1.1 (i)	"Dormant"	"Dormant" means account where there has been no financial activity and no movement of transactions for a period exceeding 12 months / 1 year. For the avoidance of doubt, financial activity includes withdrawal of cash at a branch or ATM, payment in by cheques or ATMs and does not include automatic payments of dividends.
9 (i)	Dormant Account	(i) Perbadanan TAIB reserves the right to apply such service charge as determined at its sole discretion for Account(s) which are inactive ["Dormant"] for 12 months/ 1 years and impose additional requirements for the re-activation of the account(s).

If these accounts are still inactive after 12 months, the accounts are considered as **Dormant** and a service fee of **BND\$10.00** will be charged to the account. If you wish to reactivate the dormant account, the activation charges will be **BND\$15.00**.
